NOTICE TO THOSE INDIVIDUALS REQUESTING ACCESS TO TRIBAL LANDS:

Allow 7 business days for an Access Permit to be processed from the time of submission; if there is a deadline submit accordingly. Please include names of every individual who might be on tribal lands at any time during your requested date(s) and provide specifics required of the land and vehicle description.

If ANY information is missing the Access Permit will not be processed.

Only individuals and vehicles listed will be allowed access to listed locations, failing to apply these regulations will require immediate revocation of the Access Permit.

No firearms, weapons and/or bows & arrows of any nature shall be transported on Indian land. Hunting, fishing, firewood gathering, sightseeing or any other form of transportation for recreational purposes is strictly prohibited without specific written authorization from the Business Committee or Fish & Wildlife Department.
